## NextGen Beginning Farmer/Rancher Tax Credit

- When leasing to a beginning farmer or rancher, the asset owner will receive a refundable tax credit equal to 10% of the cash rent, or 15% of the value of the share rent received each year for three years. The beginning farmer will receive a three-year lease, up to a \$500 tax credit reimbursement for an approved financial management course, and may apply for the Personal Property Tax Exemption. Forms are due November 1<sup>st</sup>.
- Both cash and share rent agreements would qualify. Examples are share crops and share cattle (share cows where the beginning farmer/rancher would get a percentage of the calf crop).
- Other assets that qualify are crop ground, pasture ground, equipment, and grain bins
